5. Commissioners Reports & Invited Guests:

Mark Spikerman and Mark Grimm with Gilmore Bell joined the board to discuss the potential creation of a Port Improvement District (PID) at the Jefferson City Conference Center site. The proposed PID would impose a 1% sales tax for 40 years, with expected annual revenues exceeding \$150,000 in the first full year of hotel operations. These revenues would be pledged to support project bonds.

The proposed steps to establish the PID include:

- 1. **Port Commission Meeting** #1 Set a date for a public hearing.
- 2. **Port Commission Meeting #2** Hold the public hearing and authorize the filing of a petition to create the PID.
- 3. **Petition Filing** File the petition with the Circuit Court.
- 4. **Court Review** Circuit Court confirms the PID is not illegal and certifies the sales/use tax question for a vote.
- 5. Sales/Use Tax Election The City, as the sole property owner, will vote on the tax.
- 6. **Port Commission Meeting #3** Approve the Financing Agreement for the Project Bonds.

The Port Authority could receive an administrative fee, estimated to be between \$2,500 and \$5,000 annually, to manage the PID funds. This account would be maintained separately from the Port Authority's general revenue account.

Following the discussion, Jon Hensley moved to begin the process to create the Port Improvement District in support of the Jefferson City Conference Center Project. Jeff Naught seconded the motion, and it passed unanimously.

The next Port Board meeting will be October 3 at 9:00am to continue the PID process.

WHEREAS, the City of Jefferson, Missouri (the "City"), has requested that the Heartland Port Authority of Central Missouri create a port improvement district (the "PID") pursuant to Sections 68.200 to 68.260 of the Revised Statutes of Missouri (the "Port Improvement District Act") on certain property located at 201 Madison Street, 210 Monroe Street and 200 Commercial Way in the City to assist in the financing of a conference center, hotel and parking facility to be developed on that property (the "Project"); and
